INDEMNIFICATION OF OFFICERS, COMMITTEES AND MEMBERS

I UNDERSTAND the foregoing right of indemnification shall not be exclusive of the rights to which any member or officer of this club may be entitled as a matter of law.

I UNDERSTAND that kart racing is a hazardous sport and **AGREE** to assume all risks involved in connection with participation in karting events. Further, **I UNDERSTAND** that I am fully and solely responsible for arranging for medical insurance or any other form of insurance, as the WEST COAST KART CLUB does not provide or arrange for any kind of insurance for me.

I AGREE to relieve the WEST COAST KART CLUB, its members, officers, agents, servants and those officiating in the karting events of all liability for losses or damages of all and every description, including but not limited to, any injury (including loss of life), and the loss of or damage to my personal property however caused, including negligence of the WEST COAST KART CLUB or any of its members, officers or agents.
