Indemnification of Officers, Committees and Members

I understand and agree that no officer, committee member or general member of the West Coast Kart Club shall be personally liable for any of its debts, obligations and/or acts.

I understand and Agree that each member and officer of the club, whether or not then in office, including their heirs, executors and/or administrators, shall be and is hereby indemnified by the club against any and all costs and expense, including but not limited to counsel fees reasonably incurred by or imposed upon the individual with or resulting from such action, suit or proceeding, to which they may be made a party by reason of their being, or having been, a member or officer of the club, including costs and expenses paid in connection with the settlement or compromise of any such action, suit or proceeding, provided that nothing contained herein shall protect, or be deemed bad faith, gross negligence, or reckless disregard of the duties involved in the conduct of their offices.

I understand the foregoing right of indemnification shall not be exclusive of the rights to which any member or officer of this club may be entitled as a matter of law.

I understand that kart racing is a hazardous sport and to assume all risks involved in connection with participation in karting events. Further, that I am fully and solely responsible for arranging for medical insurance or any other form of insurance, as the West Coast Kart Club does not provide or arrange for any kind of insurance for me.

I Agree to relieve the West Coast Kart Club, its members, officers, agents, servants and those officiating in the karting events of all liability for losses or damages of all and every description, including but not limited to, any injury(including loss of life), and the loss of or damage to my personal property however caused, including negligence of the West Coast Kart Club or any of its members, officers or agents.

Cost for a Day Pass is \$60.00 +HST which is to be paid to the Caretaker or Dealer. \$40.00 from the Day Pass will be applied to an annual membership if purchased within 30 days.

This Form must be accompanied with executed general waiver form(s), terms and conditions acknowledgment form and received by West Coast Kart Club prior to entering West Coast Kart Club facility.

*Minor Participant, Annual Parental Consent Waiver forms in addition to the general waiver form, terms and conditions acknowledgment form are required for minors under the age of 19.

Guest must sign up with the Caretaker or be with a Dealer or Dealer Employee at all times.
